It is for the information of all the registered candidates desirous of seeking admission to MD/MS courses in Government/Government Aided/Private Unaided Medical Institutes including those under Private Universities i.e. SGT University, Budhera, Gurugram and Post MBBS DNB/Post MBBS Diploma/Post Diploma DNB courses in Civil Hospitals for the Academic Session 2021-22 that the following is list of documents to be brought at the time of reporting before Admission Committee:-

1. Matriculation Certificate/High School/ICSE/Class X or its equivalent certificate as proof of date of birth.
2. Certificates of having passed MBBS examination from Institution recognized by NMC.
3. Three copies of the recent photographs (passport size) self attested used for NEET form.
4. Internship completion certificate certifying the date on which the candidate has completed one year Compulsory Rotatory Internship. The date of completion of internship training as notified by MoHFW NMC i.e. upto 30.06.2021. .
5. Foreign Medical Graduate Exam result (if applicable).
6. Character certificate of the Head of Institution last attended/First Class Executive Magistrate.
7. Resident certificate issued by competent authority of the State Government of Haryana(if applicable/bonafide resident certificate issued by the competent authority of the State Government(if applicable).
8. Certificate of Registration with any State Medical /Council/NMC at the time of counseling.
9. Caste Certificate issued by competent authority of the Haryana State Government (if applicable).
10. Certificate of Dependent of Fighter Certificate issued by competent authority of the Haryana State Government (if applicable).
11. Certificate of ESM issued by competent authority of the Haryana State Government (if applicable).
12. Creamy /Non-creamy certificate for BCA-A/BC-B category candidates as per Govt of Haryana notification dated 17.11.2021. Certificate issued after 17.11.2021 will only be considered.
13. Income and Asset Certificate for EWS candidates issued by competent authority.
14. Annual Income certificate for the candidate (BC-A/BC-B/SC/SC-D) category under PMSS(Post matric scholarship scheme).
15. Certificate of Disability issued by notified centers by NBE or Medical Board at PGIMS,Rohtak (if applicable).
16. Result card of NEET –PG 2021.
17. HCMS category candidates must produce valid NOC alongwith the certificate of length of service rendered in the remote and or difficult areas or rural areas notified by the State Government, to be issued by the competent authority failing which the in service candidate shall be considered ineligible for counseling.
18. As proof of identification Aadhar card/PAN card/Driving license/Passport/Voter ID/Ration Card/Parivar Pehchan Patre.
19. Printout of Application form.

For NRI/OCI/PIO Category Candidates following documents are required in additional to above mentioned documents:-

1. Passport.
2. Documentary evidence/certificates of NRI/OCI/PIO as per Govt. of India instructions issued from time to time.
3. Sponsorship affidavit from NRI stating that sponsorer will bear all the expenses for the whole duration of study (If applicable).
4. Relationship affidavit (Relation of candidate with sponsorer with family tree and supportive document evidence) if applicable.
5. Proof of NRE/NRI Bank Account.

Please note that due to non-availability of above mentioned documents at the time of document verification, the candidature as NRI candidate will not be considered.

NOTE:- PERSONAL APPEARANCE OF THE CANDIDATES ALONGWITH ALL ORIGINAL DOCUMENTS BEFORE AT THE ADMISSION COMMITTEE AT PT. B.D.
