**Counselling for admission to MDS Courses in all Government/ Government Aided/ Private Unaided Dental Institutes including those under Private Universities - SGT University, Budhera, Gurugram, PDM University Bahadurgarh, Jhajjar in the State of Haryana for the Academic Session 2021-22.**

It is for the information of all the general public that the State Government has notified NRI Quota in admission to PG Courses (MD/MS/MDS) under Private Medical/Dental Colleges including those under Private Universities i.e. SGT University, Budhera, Gurugram and PDM University, Bahadurgarh in the State of Haryana vide notification dated 01.10.2021. Accordingly it is for the information of the candidates desirous for seeking admission under MDS Course and all other concerned that admission portal for fresh registration for MDS Course has again opened for the academic session 2021-22. The fresh schedule of registration is as under:-

**Note:** The registration fee for NRI applicant is Rs. 10,000/- per candidate.  
The course fee for NRI candidate shall be same at par with the management category seat.  
Already registered candidates can submit their fresh choices and edit their already registered application as per the schedule mentioned above.

The detail of further counselling process i.e. document verification/allocation of seats/ deposition of Fee/ last date of joining etc shall be notified later on. All candidates should ensure to upload all requisite original documents on the Admission Web Portal. For NRI candidates the requisite document clearly indicating the status of NRI/OCI/PIO/Nearest Relation has to be produce to the Admission Committee at the time of document verification failure which the candidature would be rejected.

Further, all the eligible in-service candidates at the time of applying for admission to MDS courses for the Academic Session 2021-22 in the State of Haryana shall be required to upload valid NOCs and Experience Certificates issued by the Competent Authority i.e. Health Department, Haryana/ESIC/Concerned Departments, Organizations and autonomous bodies as per their respective Post Graduate course admission policy for in-service candidates.
